WORKING WITH THE OFFICE OF THE U.S. SPECIAL ENVOY FOR SUDAN, DPDO CONTINUED REBEL UNIFICATION AND CIVIL SOCIETY ENGAGEMENT THROUGH MEETINGS IN ADDIS ABABA, TRIPOLI, AND CHAD, WHERE REBEL FACTIONS FORMED A TECHNICAL COMMITTEE TO HOST A UNIFICATION CONFERENCE IN DARFUR. THOSE EFFORTS BECAME THE CORNERSTONE FOR GATHERING IN DOHA, QATAR IN MARCH 2010. THE MAJORITY OF EXPENSES FOR THE PEACE PROCESS WORK IN 2009 WENT TO TRAVEL, LOGISTICAL, AND COMMUNICATIONS EXPENSES. DPDO ALSO RECEIVED A DONATION OF \$17,438 FROM GEORGETOWN UNIVERSITY 'STAND', AN ON-CAMPUS
